Purpose, Objectives & Implementation

Purpose:

Encourage all levels of the organization, especially girls and young women, to learn about and engage in the governance process of WAGGGS in an educational and fun way.

By engaging more girls and young women at all levels in understanding about the World Conference, there are more girls and young women who are ready and willing to play an active role in supporting their Member Organization. This is also in-line with the effort of the *Motion 32* working group, which is to encourage and empower more girls and young women to step up in the governance area.

Objectives:

By completing activities in the learning pack, participants would:

- Understand the governance process involved in the WAGGGS World Conference, including having studied documents like the Constitution and the Rules of Procedure.
- > Be brave to share their own views and speak up for what matters for them.
- Learn to work and make decisions collaboratively within their teams.
- Respect the values of democracy and appreciate the diversity within the organization by studying and trying to understand the opinions of others, while reflecting on your own opinions and how to find a balance in making decisions for the wider organization.
- Practice the WAGGGS Leadership Mindsets in making decisions for themselves and others.
- Be inspired to engage in the decision-making process at all levels of the organization now and in the future.

<u>Activity 1:</u> The World Conference

The World Conference is held every three years and World Conferences are the key part of policy making for WAGGGS. Delegates of Member Organizations come together at the conference to discuss and vote on the key decisions that make WAGGGS a stronger organization.

What happens in a World Conference?

Under normal circumstances, attendees will gather in the same place, have conversations and make decisions in person. Here is the list core business during the World Conference:

- Discuss and vote on proposed motions
- Elect the World Board Members
- Vote on the next World Conference host
- Updates and reports from the World Board on the status of WAGGGS

The 37th World Conference is the first virtual world conference due to the current situation of pandemic.

Rules of procedure :-

- The purpose of the Rules of Procedure is to facilitate the handling of the business of the World Conference and establish the way of decisions will be taken in line with the requirements of the WAGGGS Constitutions and Bye-laws.
- These rules ensure a clear, democratic and transparent decision-making process and provide clarifications of attendance, circulation of information, and voting procedures at the conference.
- Member Organizations are expected to become familiar with the Rules before they are approved at the start of the conference. Amendments to these Rules cannot be proposed at the conference.
- The Rules give further clarifications on attendance, quorum, languages, documents, key
 roles and responsibilities, proposed motions and amendments, voting, election of the
 World Board, closed sessions, and usage of social media during the conference.



Here are key summary of each sections:

Attendance	One (1) Head Delegate, One (1) Delegate and maximum of Ten(10) observers. A total of maximum 12 individuals to attend World Conference from each Member Organizations.
Quorum	One-third of the Member Organizations that entitled to vote present at the conference.
Languages	Arabic, English, French and Spanish. All documents will be in these languages. Simultaneous interpretation will be provided in these languages during conference.
Key Roles and Responsibilities	 <u>Conference Chair and Vice Chair</u> Ensure the smooth running of the conference. <u>Procedural Team</u> Support Member Organization in understanding the Rules of Procedures and work with them on Proposed Motions and amendments before and during the World Conference. Prepare the final record of all decisions made after the conference. <u>Tellers</u> Count and verify the results of each vote and report the results to the Conference Chair.
Voting	 Only Head Delegates can vote. Majorities – if a proposed motions and amendments related to the change of Bye-Law and Constitutions, it needs 75% or more support for it to carried.
Closed Sessions	Only Head Delegates, Delegates of the eligible voting Member Organizations, the World Board and WAGGGS Staff may attend the closed sessions. During the closed sessions, the communications with others beyond this group will be restricted including social media.

Some Fun Facts of World Conference

- The First World Conference was held in 1920 in Oxford under the mandate of International Council it took place every 2 years.
- WAGGGS came into picture in 1928. Since then, a World Conference takes place every three years.
- World Conference is mentioned in Bye-Law III which details the attendees, programmes and agenda, and rules of procedure.
- WAGGGS has it first virtual conference in 2021 due to the pandemic
- All the procedures and mandates to the roles in World Conference is from Rules of Procedure where simple majority is needed to form the voting strength at the beginning of the conference.

Notes to leader:

The information can be overwhelming, leaders who are doing the activities could start with a light information session such as bingo to motivate learners to know more about the World Conference. One of the activities for your consideration is bingo.

World Conference Bingo

What do I need to prepare?

- ✓ Paper / Grid for Bingo (please see example)
- ✓ Pen / Marker
- Questions and answers

Instructions


- 1. Each learners needs a piece of paper with a Bingo grid.
- 2. Leader reads out key answers and learners put those answers into the grid randomly.
- 3. Leader reads the question and its answers.
- 4. Learners mark the answers accordingly on their Bingo grid.
- 5. The first person to get a full row shouts Bingo! and the learning process continues until all questions are discussed.

What are their reasons? How are their reasons similar or different to yours? Did they consider factors you didn't, vice versa? Questions post the Debate: Did you change your vote now that you have heard from the other teams?



Activity 4: Compass 2032

What is Compass 2032?

Compass 2032 is the new vision statement for the Girl Guide and Girl Scout Movement. It will act as a pointer along the path that every Member Organization and the WAGGGS Global Team will travel from 2021 to 2032. In the lead up to World Conference MOs have been asked to vote on the approval of Compass 2032 via Written Resolution.



"Our vision is an equal world where all girls can thrive."

By 2032 we will be a girl-led Movement where every and any girl feels confident to lead and empowered to create a better world together.

Guiding questions:

- What does an equal world look like to you?
- What do you imagine when you hear "all girls can thrive"?
- How do you think you can be confident and empowered as an individual, within your Girl guiding/Girl Scouting group and in the world?

Did you know about Compass 2032 before this? What do you think about it, and how do you think it will affect the experience of guiding?



Six themes emerged through the development of Compass 2032 that are relevant in different ways to all Member Organisations and the WAGGGS Global Team. These six "Compass Conversations" are the challenges that we need to keep thinking about, talking about, and acting on, so our organisations are best placed to contribute to Compass 2032. They are conversations that will evolve over the coming years, changing as our organisations and contexts change. We hope each Member Organisation will recognise these as topics of special interest and will investigate how they are relevant in their own context. The WAGGGS Global Team will facilitate these conversations across the Movement by providing the tools, connections and spaces for all Member Organisations to discuss and share ideas on each conversation. What each organisation learns from these conversations will inform future strategies and plans.

<u>Activity 5:</u> CV for World Board Election

Things to prepare/to take note:

- **Gold Refer the World Board nominee form in Annex A**.
- □ Check if you meet the criteria especially special criteria e.g., under 30.
- □ Plan how you will get support from your Member Organization.
- □ Read through the application form thoroughly before applying.
- □ Fill up the necessary information in the form.
- If you are required to do a short video to introduce yourself or etc, ensure that you allocate sufficient time to produce the video and that it has all the necessary information.
- If you are required to write essays, what will you need to make your essays stand out?
- The CV must be focused on your experience as a Girl Guide/Girl Scout. If you already have vast experience in guiding/scouting and covering many areas e.g.: finance, planning, leadership...etc., you do not need to include your other extra-curricular activities. If you don't, then include relevant information that will support your CV.
- When selecting someone to be your referral, seek someone who will be a neutral party. The referral should know you well enough but will not gain any benefits from you being in the World Board.
- Keep it short the CV should not be more than 2-3 pages long or as stated in the document.

- Proofread your submission materials (the application form, your essays, pictures, videos, etc.).
- Send it out to the International Commissioner at least one (1) week before the due date. The International Commissioner will assist in getting approval from the Member Organization.

Reflection questions/activities:

- What are the differences between the CVprepared for the application to the World Board vs other applications?
- What are your strengths that you think can help you in winning the election to the World Board?
- Send in a CV to apply to the World Board to your leader.
- Make a video introducing yourself and why do you want to be on the World Board.


