

## Changes to the Australian Learning & Qualification Program

Girl Guides Australia's Mission of empowering girls and young women to discover their potential as leaders of their world is as pertinent now as it ever was. To support the implementation of the Mission there has been some review and minor changes to the language of the ALQP to better support the work of our Volunteers to facilitate the Australian Guide Program.

There has also been a review of the Role Descriptions and Passports for the roles of Region Manager and District Manager to reflect current volunteering and Guiding needs and outcomes (details below). The Leader Role Description and Passport has been updated to reflect the Manager Role Descriptions and Passports. Thanks is extended to the volunteers who provided their expertise and contributed to this project.

### Language Changes 2021

The Australian Learning & Qualification Program (ALQP) has been renamed Australian Leadership & Qualification Program (ALQP).

The Program is designed to enhance the Leadership pathway for Adults in Guiding, whether they be qualifying as Leaders, Managers, Trainers or to facilitate outdoor activities.

Leader – Not Yet Qualified (NYQ) and Manager – Not Yet Qualified (NYQ) have been renamed Leader in Training and Manager in Training

This title is more readily recognisable by new and current members and the terminology is more commonly used in the wider community.

#### Being Safe Training Module has been renamed Risk Awareness

This aims to support language used in the GGA Child Safe Child Friendly Framework and to add clarity to the language around our risk awareness for Leaders and Managers.

There is no change to the requirements for Leaders and Managers when managing risk.

#### Learning Partner has been renamed Mentor

This title is a departure from the legacy of Guiding Partner. The role of Mentor is well known within the wider community and again enhances the Leadership pathway for

adults in Guiding. There is no change to the requirements for Mentors and current Learning Partners will be automatically recognised as Mentors but will need to familiarise themselves with the incoming Role Description.

- LQ and MQ trainings will remain the same for 2021 and will move in line with the requirements for the new Passports for 2022.
- This will not impact the capability or knowledge of the existing Leaders and Managers in Training.
