

# A.GINFO 07 (2023) Values Framework Working Group

Girl Guides Australia and Girl Guides NSW ACT NT are pleased to announce the formation of a Values Framework Working Group. This Working Group is drawn from both Guiding volunteers and staff from around Australia and incorporates a spectrum of differing skillsets and Guiding experiences.

#### Why do we need a values framework?

Girl Guiding is a values based organisation. For members, the commitment to the Girl Guide Promise and Law is part of our values and is a meaningful part of a member's journey. Others who interact with Guiding, including employees, parents, and other stakeholders, support the Girl Guide Promise and Law but do not have the same connection to its commitment. By articulating our values, in a way that is meaningful to all:

- 1. Girl Guiding employees are better able engage personally and professionally with our values;
- 2. Members can be supported in engaging with the Girl Guide Promise and Law on a different level;
- 3. Parents are better able to understand the values which underpin the Australian Guide Program and the Girl Guiding movement;
- 4. External parties can better understand how Girl Guiding benefits the community;
- 5. Girl Guiding can position itself in new ways in reaching out for support;
- 6. The values articulated will support a unified approach to our activities.

#### What will the Working Group do?

The Working Group are responsible for designing consultations, collating feedback, and making recommendations from their investigations for approval. Consultations will be arranged with those who interact with Guiding around Australia to seek feedback on what are the national values that Girl Guiding aspires too. Once the Working Group has considered the feedback and drawn conclusions, they will make recommendations for consideration and approval by both GGA and SGGOs Boards later this year.

Consultations will be facilitated via SGGOs, with a broad variety of groups and individuals included.
